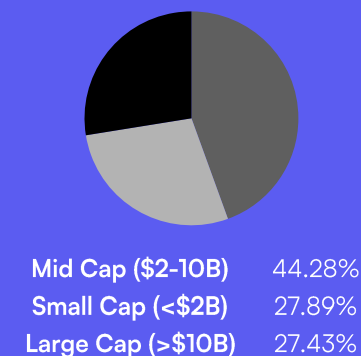
Sector Breakdown



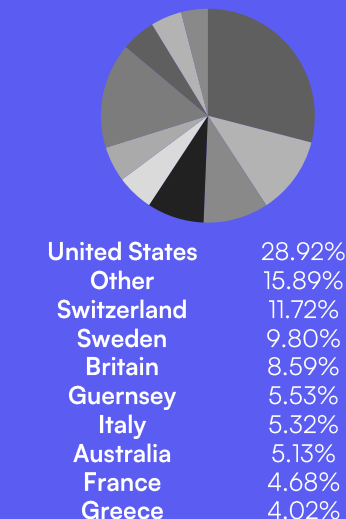
